



## Soil Swap Program

We provide clean replacement topsoil for new or existing gardens to help ensure food crops are grown in safe soil. We also provide sand boxes and clean sand so children can have a safe place to play and dig.



## **Blood Lead Monitoring**

Free blood lead monitoring services are available for anyone living within or around Anaconda. These services are provided at the Community Hospital of Anaconda.





We provide the public with cleanup information. This includes sampling, remedy, and property assessment data.



## **Interior Dust Program**

Renovating or Remodeling? Let us help guide you in lead safe renovation techniques to minimize the spread and exposure to potential lead dust. We offer free Renovation Kits and have HEPA vacuums we loan out for free to help reduce the exposure to lead dust.

We can also conduct a free home assessment as part of the Interior Dust Program for anyone concerned with lead exposure or if anyone in the residence has been tested and has an elevated blood lead level.

## **Domestic Well Plan**

We help determine if residents live within the Domestic Well Overlay and submit Test-by-Request well sampling inquiries to Atlantic Richfield for free arsenic sampling of your well.

# Coordinating Superfund Cleanup Efforts

Coordinating with you, the County, and Atlantic Richfield on soil and attic sampling requests. We provide you the sampling results and domestic well sampling information. We will answer your questions and help guide you through the cleanup process.



## Weed Reimbursement Program
